#### I. Opening Prayer

# II. Call to Order – IBM Chairperson

Tisha served as host, began with prayer, and called meeting to order.

# III. Approval of IBM Minutes

Kerry shared the minutes from the November meeting. Members shared feedbackand edits were made to November minutes. Concerns around Christian fellowship issue that had been raised, pausing meetings whose host has not attended for 3 consecutive meetings. South Africa meetings. Kerry agreed to post minutes a week before IBMs so that less time will be taken with reviewing.

### V. Committee Reports:

- a. Website
  - Dominic needs clarification re: what kinds of videos can be approved. Context → Desire expressed to compile videos that hosts can use for meetings. Links were decided upon as the best route. Now we're ready for approval of each video.
    - 1. Would we need someone to approve the videos?

(There is a Google Drive with links that hosts can access and add to, and Tisha had conceived of this as something similar. Opened the floor for feedback.)

- 2. Pooja suggests downloading the transcript of videos and treating it like an article that can be uploaded. She does not feel confident using non LAA-reference material as such.
- Vincent wants us to be conscious of bandwidth, how website is used...Doesn't think videos should be posted on the website. Hyperlinks are preferable. Doesn't think approval should be necessary.
- 4. Dominic says embedded videos wouldn't affect the bandwidth of the website. He just wants to know about approval why would one person get to decide?
- 5. Bianca echoed Dominic's point re: embedded videos. Wonders if the website committee would be responsible for approving videos.
- 6. Antranette People making videos are in business. How can we ensure it's good for our fellows and aligned with the traditions?
- 7. Tisha if you're willing to help Dominic with some recommendations around this process, reach out to him directly or communicate in the chat.
- b. LAA Literature
  - i. There is still the outstanding change of the promises literature. Someone submitted something for consideration but now going back to the drawing board.
